Supporting Community Resilience in the South Caucasus VFL 2013

The project "Supporting Community Resilience in the South Caucasus" has been launched on December, 25 2012 in Armenia. The regional project on "Views from the Frontline 2013" funded by Swiss Agency for Development and Cooperation (SDC), to be implemented in Armenia and Georgia by Regional Environmental Center for Caucasus (RECC) in partnership with OXFAM GB, and the Global Network of Civil Societies for Disaster Risk Reduction (GNDR).

The Project aims to support the effective implementation of the HFA to build the resilience of vulnerable people and communities at-risk to disasters, especially to provide a global overview of progress in Local Level Action to reduce "extensive" disaster risk, to model a local change process and build local capacities for action and learning; to raise awareness and understanding of disaster risk reduction and community

resilience; to increase participation, dialogue and relationships between different state and non-state actors responsible for reducing risk.

The National Training Workshop focused on presentation of VFL 2013 project implementation setup, VFL 2013 data collection and inquiry methodology. as well demonstration of previous VFL. experience and results has been organized within the project for civil society representatives, community based organizations, NGOs and grassroots working in the field of disaster risk reduction and preparedness. During the workshop, project Participating Organizations (POs) were also provided instructions on the methodology of conduction of project activities, including community surveys, data collection through questionnaires, as well as provision of findings and case studies on a basis of surveys to be held in target five regions of Armenia. The start was very promising and productive as it created firm background for future progress.

Seventh Session of Professional Capacity Building Training for Environmental inspectors

REC Caucasus Armenia National Office in close co-operation with Ministry of Nature Protection of Armenia and State Environmental Inspection agency organized the seventh session of professional trainings for environmental inspectors on 18-19 December, 2012 within the regional project on "Establishing a structured approach towards training of environmental Inspectors in Armenia" funded by the Norwegian Ministry of Foreign Affairs.



Training Program was focused on demonstration of modules, case studies on identification of conflict situations during environmental inspection and analysis; assessment criteria of leakage of water resources; functions of inspectors in illegal poaching; compliance and differences and RA legislation, of EC applicability of rules, available EC supporting tools, as well as presentations on National and EU environmental legislation. (IPPC, directives Environmental liability, Best available techniques Legal field regulating Environmental inspectorate control procedure, Environmental and natural resource use fees, financial-economic mechanisms inspectorate. of Trainings cover cooperation initiatives of RA Ministry of Nature protection with international organizations, implementation of selfcontrol towards compliance with the

requirements of environmental



legislation, accompanied with practical group works information on co-operation between local national agencies in the sphere of environmental inspection, legislation frameworks regulating environmental inspection, organization of work within environmental inspection/ institutional issues. All the selected topics are meant to contribute to the strengthening and enhancement of SEI performance. Environmental inspectors were awarded certificates signed by the Minister of Nature protection Mr. Aram Harutyunyan and RECC Executive Director, Ms. Harutvunvan. Relevant authorities in the field recognize certificates as documents certifying professional knowledge qualification.

Project Closure Workshop

The closure workshop on Norwegian Government funded regional project "Establishing a structured approach towards training of environmental Inspectors in Armenia" has taken place on 26 December at RECC Armenia National Office premises.



The project implemented in 2011-2012 was focused on introduction of structured approach towards trainings for the employees of the State Environmental Inspectorates of

Armenia based on training needs assessments, development of multitraining program and implementation series of of professional trainings and successfully accomplished. The closure workshop was focused on demonstration of the overall project implementation, project impact on RA SEI better performance and achievements; project legal aspects, EU Directives, case studies, project tools applied /SEI capacities to comply with Flora and Fauna protection requirements; tangible results as well as presentation on program-based training recommendations, best practices and project bilingual web portal.



The closure workshop has gathered together different stakeholders, including representatives of the RA Ministry of Nature Protection, SEI, Yerevan Municipality, Environmental Law Research Centre at Yerevan State University; Institute of Hydroecology and Ichthyology; "Green Lane" NGO; Asian Development Bank; Foreign Financing Projects Management Centre SI, Ministry of Finance. AWHHE NGO: **WWF** Yerkir.am, Armenia. Agrarian University of Armenia. "Environmental project implementation unit" SA, USAID Armenia and etc.

While considering project effectiveness and positive impact, the major emphasis was put on ideas suggested, recommendations made and possibilities reviewed by workshop participants for project continuity.



Closure workshop on EU funded FCFPP regional workshop

REC Caucasus Armenia launched a closure workshop on the EU funded "Foresting community Forest policy and Practice in Mountain regions of the Caucasus" Regional Project at Russia Hotel in Tsakhkadzor town, Armenia.



The progress towards achievements of sustainable forest management, its methods and approaches applied as well as results of CFM planning, actions. sustainable grassroots and approaches methods community based forest management, including methods of landscape restoration and reforestation for natural disaster prevention, positive impact of project intervention, as well as film presentations on the best practices on sustainable use of forests, community forest management and reforestation have been demonstrated during the workshop.



The Closure Workshop put emphasis on the specific goals of the FCFPP regional project, mainly raising overall awareness on the activities undertaken that responded to current demands of the countries in elaboration of relevant to institutional, and technical set-up for community forest management, in raising awareness and capacity building of local communities and local authorities on sustainable forest management and demonstration of best approaches of immediate reforestation and landscape restoration in areas affected by landslides, mudflows, avalanches and other natural disasters preventing measures. The Deputy Minister of the Ministry of Nature Protection, Mr. Khachik Hakobyan, Adviser to the Minister of the Ministry of Nature Protection Mr. Samvel Amirkhanyan, the Chief Forester of Hayantar SNCO under Ministry of Agriculture, Mr. Rubik Petrosyan, RECC regional Director, Ms Nune Harutyunyan, RECC board member, Ms Dshkhuhi Sahakyan, and project national expert team, as well as representatives from different organizations, World Bank, Local NGOs, LSG of Koghb and Jujevan communities have attended workshop.

The Workshop has also drawn participants' attention on reforested and restored landscapes, in two communities of Koghb and Jujevan, in Tavush region. The workshop contributed to strengthened formal and informal exchange on forestry related issues between the project's national stakeholders thus providing platform for sharing experience and potential mutual support, common visions related to community forestry management and forest protection in the national and regional context, as well as shared view regarding the best available sustainable community

management forms, related policies and practices that could be applied at the national level.

The project closure workshop was also specified with screening of Social Advertisement Video Clip on sustainable forest management, forest conservation and other forest related topics aimed to address deforestation and climate change issues.

National Workshop within Agrobiodiversity regional project

RECC Armenia has launched National Workshop on Agrobiodiversity regional project on 29 November 2012. The National Workshop has taken place in the project pilot region, Vayots Dzor.



The major goal of the National Workshop was to demonstrate outline climate-change adaptation measures to be implemented in the pilot communities of Paruyr Sevak and Rind (Ararat and Vavots Dzor discuss regions), as well as implementation of pilot adaptation projects approved by the Project Steering Committee. Besides this, project latest achievements, short film highlighting project positive impact, community members' expectations project implementation, from prepared by an Armenian InterNews Media Support NGO and further activities were also presented by the project team. More than community members have attended national workshop and received information materials including project leaflets, bilingual newsletters and other project related materials.
